Support rate	For organizations established by local government units, a 15 % contribution is set. For other recipients, the contribution is 0%.

Other conditions	Projects supported in this call apply a 40% flat rate, the rules of which are described in the Manual, the project must not generate profits; the beneficiary will receive a 30% advance of the total eligible costs after sending the Decision on the Provision of a Subsidy via the data mailbox.
